RULES

(Made under section 14(1)

THE COLLEGE OF BUSINESS EDUCATION (EXAMINATIONS) (AMENDMENTS) RULES, $2024\,$

Citation GN No. 926 of 2023 1. These Rules may be cited as the College of Business Education (Examinations) (Amendments) Rules, 2024 and shall be read as one with the College of Business Education (Examinations) Rules, 2023, hereinafter referred to as the principal Rules.

General amendment

- 2. The principal Rules are amended generally by-
- (a) deleting the word "NACTVET" wherever it appears and substituting for it the words "National Council for Technical and Vocational Education Training";
- (b) deleting the word "NTA" wherever it appears and substituting for it the words "National Technical Award"; and
- (c) deleting the word "TCU" wherever it appears and substituting for it the words "Tanzania Commission for Universities.".

Amendmen t of rule 3

3. The principal Rules are amended in rule 3 by deleting the definition of the term "abscondment" and substituting for it the following:

"abscondment" means not sitting for scheduled examination, or failure to attend scheduled classes to the required percentage or failure to postpone studies without reasonable cause supported by sufficient evidence.

Amendmen t of rule 14

- 4. The Principal Rules are amended in rule 14 by adding immediately after sub rule (12) the following:
 - "(13) A student who is aggrieved by the conduct or assessment of continuous assessment in the module-
 - (a) shall within five days report the matter in writing to the respective module instructor for timely resolution;
 - (b) where the student is aggrieved by the decision of the module instructor or the module instructor fails to resolve the matter within seven days from the date of reporting the matter, the student shall within five days report the matter in writing to the respective Head of Department;
 - (c) where the student is aggrieved by the decision of the Head of Department or the Head of Department fails to resolve the matter within seven days from the date of reporting the matter, the student shall within five days report the matter in writing to the DRARC for final decision."

Amendmen t of rule 18

- 5. The Principal Rules are amended in rule 18 by adding immediately after sub rule (8) the following:
 - "(9) A student aggrieved by the conduct of the field work, project, research or dissertation-
 - (a) shall within five days report the matter in writing to the respective supervisor for timely resolution;
 - (b) where the student is aggrieved by the decision of the supervisor or the supervisor fails to resolve the matter within seven days from the date of reporting the matter, the student shall within five days report the matter in writing to the respective Head of Department;

(c) where the student is aggrieved by the decision of the Head of Department or the Head of Department fails to resolve the matter within seven days from the date of reporting the matter, the student shall within five days report the matter in writing to the DR-ARC for final decision."

Amendmen t of rule 30

- 6. The Principal Rules are amended in rule 30 by adding immediately after sub rule (19) the following:
 - "(20) Notwithstanding the provisions of sub rule (18), the candidate may within five days from the date of an *ex parte* decision apply in writing to set aside the decision thereof, upon satisfying the Examination Irregularities Handling Committee that there was sufficient cause for such non-appearance.
 - (21) The Examination Irregularities Handling Committee shall, upon being satisfied with the application made under sub rule (20), make an order setting aside the decision and appoint a day for hearing the matter.".

Amendmen t of rule 32

7. The Principal Rules are amended in rule 32 by deleting sub rule (6).

Amendmen t of rule 45

- 8. The Principal Rules are amended in rule 45 by-
- (a) deleting sub rule (1);

- (b) renumbering sub rules (2), (3), (4) and (6) as sub rule (1), (2), (3) and (4) respectively;
- (c) deleting sub rule (4) as renumbered and substituting for it the following:

 "(4) Unless directed otherwise by the DR-ARC,
 - an appeal shall be filed to the examination office through Students' Information System upon payment of the applicable fee".
- (d) adding immediately after sub rule (4) as renumbered the following:
 - "(5) The Examination Results Appeal Committee shall determine the appeal within twenty-one days after expiry of the appeal period;
 - (6) The provisions of this rule shall not apply to matters provided under rule 14 and 18.".
